No member shall be elected by the Board of Governors unless his or her invitation to Membership has been approved by the Membership Committee. All applications for membership must be approved by the Board of Governors. No person, although duly elected to membership, shall become a member until such person shall have fully complied with conditions and provisions of the By-Laws of Trussville Country Club within thirty (30) days after notice of election.

I further understand that the monthly dues (including but aren't limited to dues, fines, assessments or charges) are due upon receipt of the 15th day of that current month. If payment is not made on or before the 15th day of the current month, then all such dues, fines, assessments and indebtedness shall become delinquent and a late charge of ten percent (10%) of the unpaid balance shall be levied against the Member's account for the respective month of delinquency. Member's account will continue to be assessed monthly late charges as hereinafter stated for each month thereafter until such time as the Member becomes more than ninety days delinquent at which time his or her membership will be terminated and said Member's account turned over for collection or further legal action. Should Trussville Country Club be forced to institute legal action for the collection of delinquent dues, assessments, damages, charges or other indebtedness the Member shall be responsible for all court cost and reasonable attorney fees associated with the collection of the Member's account.

The privileges of the Club will extended to members of the family of a Member without the payment of additional dues upon the Member registering the names with the Secretary of the various members of the family for which privileges are desired. The family of a Member includes the spouse and dependents under the age of 21, residing with the Member.
